Regulations of Members for Public Interest Incorporated Foundation Foundation for Global Children

(Purpose)

Article 1. These rules are governed by Foundation for Global Children Articles of Incorporation (Hereinafter referred to as the Articles of Incorporation). Based on the provisions of Article 49, Paragraph 3, the purpose is to determine the necessary matters concerning the Foundation for Global Children (hereinafter referred to as "FGC") members.

(Type of Members)

Article 2 The type of members prescribed in Article 49 of the Articles of Incorporation shall be supporting members.

(Supporting Members)

- Article 3 Individuals and organizations that support the purpose of this corporation and pay the supporting membership fee may become supporting members with the approval of the president.
- 2) Due to the membership fee, members will not receive profits from this corporation. In addition, this corporation shall report its activities to members twice a year by FGC News.

(Admission Procedure)

- Article 4 A person who intends to become a member of this corporation must apply to the secretariat in separate form No. 1.
- 2) A person who intends to become a member from the website must apply to the secretariat for the separate form No. 3 by application mail.

(Membership Fee)

Article 5 Membership fees shall be as listed in the attached table.

2) The dues paid shall not be refunded for any reason.

(Provision of Information to the Members)

Article 6 This corporation, in hopes that members will deepen their support for this corporation, and hope that members will spread support for this corporation to others, provide information on the undertaking to be carried out pursuant to Article 4 of the Articles of Incorporation, Call for participation in various events, such as lectures to be implemented or supported in accordance with the provisions of Article 4. (Use of Membership Fee)

Article 7 50% or more of the membership fee in Article 5 shall be used for utilities for the current fiscal year.

(Resignation Procedure)

Article 8 When a member intends to withdraw, he / she must notify the secretariat in Form 2 below. In this case, the paid membership fee will not be refunded.

- 2) If a member falls under any of the following items, it shall be deemed to have withdrawn.
- (1) When a member dies.
- (2) When the dues are not paid even after one year from the prescribed date.

(Member's Obligations)

Article 9 Members shall have the obligations listed in the following items.

- (1) We fully understand the purpose of this corporation and act.
- (2) Actively participate in the business of this corporation and cooperate with officers, etc., to strive for the development of this corporation.
- (3) Comply with the articles of incorporation and various regulations of this corporation.
- (4) Efforts will not be made to defame or degrade this corporation.

(Warning or Expulsion)

- Article 10 If a member is found to have committed an act that violates the provisions of item 3 or item 4 of the preceding article, the member will be reprimanded or expelled by a resolution of the board of directors.
 - 2) If a member is reprimanded or expelled pursuant to the provisions of the preceding paragraph, the member who is voting shall be given the opportunity to attend and excuse the board.

(Loss of Qualification)

Article11 If a member is sentenced to imprisonment or higher, he or she shall lose its qualifications.

(Supplementary Provision)

Article 12 Necessary matters concerning the implementation of these regulations shall be separately determined by a resolution of the Board of

Directors.

(Revision)

Article 13 Revision or abolition of these rules shall be determined by a resolution of the Board of Directors.

[Supplementary Provisions]

1) These rules shall come into effect on May 12, 2015.
